EXECUTIVE SUMMARY

On 26 July 2018, Councillor Melisa Hederics and Councillor Leigh Byron were elected to the position of Chairperson and Deputy Chairperson, respectively. The Deputy Chairperson position was vacated on 27 January and the position has not been filled.

In accordance with the OLG Joint Organisation Implementation Guide May 2018, the election of chairpersons of joint organisation should be held at the first meeting of the board after the term of the chairperson expires, namely 28 August 2020 and the Board must again elect a Chairperson and a Deputy Chairperson for a period of two years.
